

Introduction


Post colonialism is generally taken to be a term associated with repression, subjugation, silencing, othering, reaction and revolt. But in this work I intend to argue that colonisation is not just a repressive term, nor colonial relationship a process of subjugation and reaction alone but a relation that involves interdependence and exchange of cultural and political ideologies between the colonizer and the colonized. It is a relationship that also requires a certain degree of willingness or consent on the part of the colonized to allow the overtaking of a dominant culture. There is strangely enough an element of glorification of the colonizer by the colonized. There is a reciprocity of desire between the two countries. The desire of the colonizer for the colonized is understandable because the colonized is generally a nation rich in natural resources. But there is a queer desire of the colonizer for the colonized that amounts to a gaze for the 'Imperial Other' which is the source of nurturance. The intention of the work thus is to light upon a new angle of postcolonial relationship where the colonizing nation becomes a 'Mother Nation' or 'Father Nation' and the colonized inspite of being rich in resources looks upon it for nurturance. In such circumstances there grows a dependence between the two nations. Even in the postcolonial era this dependence exists through a process of cultural exchange that results in the emergence of a hybrid state.

This leads to the idea of adaptation. The colonising power gradually infiltrates into the colony through such machineries as the church, the school, family and later through political institutions. It engages the colonized to adapt and appropriate these foreign tools like colonial education, religion, governmental control and effect a total changeover of the traditional indigenous system. In the field of politics specially for the unreachable tribal areas in the colonisers like England used the tribal chiefs to act as 'puppet thiefs' on their behalf. England for instance, ruled the tribal nations through

Karl Marx and the Theory of Surplus Value

Simanti Bandyopadhyay

The everlasting contribution of Karl Marx to the theory of economics is that he drew attention to the problem of reproduction of the entire social capital. In the history of economics, two significant attempts have been made at an exact exposition of this problem: one by Quesnay-the father of physiocrats-at the beginning and at its final stage by Karl Marx. The bourgeois economists in the interim had never been able to formulate this problem precisely as they were not aware of this problem.

The literal meaning of the word reproduction is repetition or the renewal of the process of production. However reproduction is something more than mere repetition in so far it presupposes certain standard of labour productivity.

In a primitive communist agrarian community, reproduction is determined by the community of all workers and their democratic organs. The decision to re-engage in labour, the arrangement of reproduction and the determination of its volume are all results of a planned co-operation in which everybody within the community

In a slave society reproduction is enforced by personal relations of domination. In every society known to history, other than a capitalist one, reproduction recurs in a regular sequence as far as its preconditions, the existing means of production and labour power make it possible.

The capitalist methods, however, present a different picture. Reproduction here depends on purely social considerations. Only those goods are produced which can be expected to sell with certainty at a customer which can be expected to sell with certainty at a customary profit. Therefore, profit is the decisive factor which determines not only production but also reproduction.

The Capitalist Mode of Production

The capitalist reproduction comprises not only production but also circulation or exchange in comprises not only production but also circulation or exchange. It is organized primarily by innumerable

The Concluding Hymn of the Vāmadeva-*maņḍala*(RV IV.58)–A New Appraisal

Introduction

The Rgveda, the oldest literary monument is divided into ten mandalas. Amongst them the mandals ranging from II to VII are commonly designated as 'Ārṣamandalas' or 'Family Books', since each of them is ascribed by tradition to one particular seer or one particular family of seers. Thus, mandala IV, consisting of fifty eight hymns, is traditionally attributed to seer Vāmadeva and his family. Each of the Family Books has its own characteristics and peculiarities which clearly distinguish one from the other. Like the other Family Books mandala IV also is endowed with its own charm and is chracterised by its peculiarities. This paper presents a modest deliberation on the main theme of the concluding hymn of the Vāmadeva-mandala (IV.58) and attempts also to reveal the philosophical spirit and mysticism involved therein.

Introduction: Through ages women took similar pains along with men in establishing human civilization throughout the world, but they remained largely dependent on men-folk. In recent times the question of inequality of genders and the exploitation of women have become a major topic of discussion before the society. This results in certain changes no doubt but in spite of wide spread social movements and measures to reduce the inequality and exploitation of women the situation is still far from satisfactory. The social customs, religious restrictions, the patriarchal structure of the family organization have contributed to the social degradation of women in Indian society.

Women's health is inextricably linked to their social status. In many parts of the world, particularly in South Asia, discrimination against women starts before birth and continues until death. In most regions of South Asia, women are denied the rights and privileges afforded to their male counter parts both within and beyond the domestic sphere. Throughout their lives women endure discrimination based on gender which includes basic necessities of life like food, clothing and education. Further; South Asian women suffer greatly from a lack of access to health care-particularly in rural areas. Women often face traditional taboos, based on cultural practice and religious belief against consulting doctors. This is one of the main reasons behind the high rate of morbidity and mortality of women in South Asia. In India the most common diseases for women are diarrheal diseases, respiratory infections and prenatal conditions (complications or diseases that occur at or after twenty eight weeks of gestation or within the first seven days after birth).^[1]



সামাজিক ক্ষেত্রে নারীদের অধিকার প্রতিষ্ঠার লড়াই সুপ্রাচীন কাল থেকে চলে আসছে। মূলতা সৃষ্টির আদি পর্ব থেকেই সমাজ পরিচালনার ক্ষেত্রে পুরুষের একক প্রাধান্য বজায় থেকেছে, _{গশাগা}শি নারী থেকে গেছে পুরুষের সহযোগী হিসাবে। সৃষ্টির প্রথম পর্যায় থেকে পুরুষের এই কৃত্ত্ব কি প্রকৃতির বিধান ? নাকি সমাজ নির্মিত তথাকথিত ভ্রান্তি ? প্রাচীন হিন্দু শাস্ত্রে এ বিষয়ে কি নাখা দেওয়া আছে সে সম্পর্কে আলোকপাত করতে গিয়ে প্রথমেই হোঁচট খেতে হয়। কারণ গ্র্টানতম ভারতীয় বা হিন্দু সাহিত্য হল বেদ। যার রচনাকার হিসাবে বলা হয়, বেদ অপৌরুষেয় জ্রন্ধার মুখ নিঃসৃত বাণী। তাহলেই কি প্রাচীনতম ভারতীয় সাহিত্যের সৃষ্টি নারীদের দ্বারাই দৃষ্টও ঋষিদের কাছে ধ্যানের মাধ্যমে প্রতিবাদ হয়েছিল। এই কারণে বেদ অপৌরুষেয় নামেও গর্ক্তিত।' এই ব্যাখ্যাকে মান্যতা দিলে এটা পরিষ্কার হয় 'মনুষ্য সৃষ্ট' মানেই পুরুষ সৃষ্ট। অর্থাৎ ন্ট্রদের এখানে মানুষ বলেই গণ্য করা হয়নি। ভারতবর্ষের ইতিহাসে নারীত্ব শব্দটিকে সতীত্ব ও গর্ব্রতের সাথে এমনভাবে মিশিয়ে দেওয়া হয়েছে যে, নারীত্বের পৃথক কোনো অস্তিত্বই বিলুপ্তির পংখ। ত্যাগ, তিতিক্ষা, সন্তান-পালন, স্বামী সেবা ইত্যাদি শব্দগুলি নারী সমাজকে এমনভাবে ^{গিল} ফেলেছে সেখান থেকে বের হওয়া বেশ কঠিন। পিতৃতান্ত্রিক সমাজে তাই নারী কেবল গুরুর সম্পত্তি, ভোগের বস্তু আর দাসী হয়েই থেকে গেছে। তবে প্রথম থেকেই কিন্তু এই ^{গ্র্চলিত} অব্যবস্থার বিপরীত নারীদের অধিকার রক্ষার লড়াই চলে আসছে, যা 'নারীবাদী আন্দোলন' ^{নানে} পরিচিত।



Abstract

GST is an indirect tax reform which is formulated to stop the tax obstruction between States and thus create a single market. GST is a single tax on the supply of goods and services, right from manufacturer to the consumer. Credit of input taxes paid at each stage will be available in the subsequent stage of value addition which means GST is essentially a tax only on value addition at each stage. Due to the effect of GST, the lifestyles of an individual get affected. Some food item becomes the gainer and some are looser in this transformation. From the smallest entity of the economic food chain to multi – billion conglomerates, no one will stay untouched by the GST. In our study, we have segregated the household goods in five heads i.e. common consumer goods, beauty and personal care, home appliances, services and cars. The main reason for levying of taxes is to raise revenue to fund governing and/or to alter the prices to affect demand. One of the most important uses of taxes is to finance public goods and services. Since public goods and services do not allow a non-payer to be excluded, or allow exclusion by a consumer, there cannot be a market in the good or service, and so they need to be provided by the government or a quasi-government agency, which tend to finance themselves largely through taxes. Now if tax is levied directly on personal or corporate income, then it is called a direct tax. If tax is levied on the price of a good or service, then it is called an indirect tax.

Leishmania Donovani-Murine Peritoneal Macrophage Attachment Induces Parasite Specific Protein Kinase C (PKC)–Mediated Phosphorylated Proteins

Abstract

Leishmania donovani infects and enters macrophages by receptor-mediated endocytosis. Incorporation of exogenously added [³²P] orthophosphate into murine peritoneal macrophage during attachment with *L. donovani* promastigotes induced phosphorylation of certain proteins. Addition of Phorbol 12 myristate 13 acetate (PMA) activator of PKC, induced the phosphorylations. Staurosporine, an inhibitor of PKC blocked phosphorylations of these proteins. However, infection of macrophages with *L. donovani*, significantly attenuated phosphorylations of these proteins. *Phosphorylations* of these proteins were absent during attachment with other intra-macrophage pathogen, *E. coli* or *Shigella flexneri* indicating that *L. donovani* specific signals were induced in phosphorylation. These suggest that induced PKC-mediated phosphorylations signals were *L. donovani* attachment specific and signal differ significantly with intracellular replication of the parasites.

Introduction

Leishmania donovani parasite binding to macrophage and its interaction with these cells efficiently occurs with parasite binding on the surface of the host cell to mannosylfucosyl receptors and CR1 and CR3 integrin receptors.1-3 Following binding of ligands, integrin and other receptors on the host cell surface have been demonstrated to generate Tyrosine threonine specific and serine 10 phosphorylation signals necessary for the uptake of various particles.4-6 Bacterial entry in many cells were shown to occur through tyrosine specific phosphorylation signals,7-11 however, establishment of PKC-specific phosphorylation in bacterial strains as well as during leishmanial entry has not been demonstrated. Although, reports of PKC-specific phosphorylation in phagocytosis by macrophages12 and Fc receptor-mediated phagocytosis by monocytes was noted.13 The present study was therefore undertaken to investigate the protein phosphorylation pattern of murine peritoneal macrophages attachment with L. donovani during promastigotes. And demonstrated that PKC mediated specific proteins were with exogenous phosphorylated orthophosphate when murine peritoneal stimulated with macrophages were L. donovani attachment. Phosphorylations of these specific proteins were compared with the macrophages after established infection. Comparison of these specific proteins were also done to investigate whether attachment of L. donovani associated phosphorylation signals occur in other intramacrophage pathogens such as Shigella flexneri and E. coli. Visceral Leishmaniasis

Despite all efforts on chemotherapy till date, visceral Leishmaniasis caused by Leishmania donovani still remains fatal and widespread. As an intra-macrophage pathogen, the parasite is most successful in exploiting the host cell metabolism, targeting the host protein into phagolysosomal compartment and modulating its phagosome. Even today, because of the complexity of the disease antileishmanial therapy is an incomprehensible subject. The ground reality is that very few agents have adequately been assessed in clinical trials and the most effective agents have the most potential toxic effects and are difficult to administer. As an alternative approach, people are now trying to exploit several surface receptors of host cells, e.g., macrophages for activation purposes to fight against this deadly pathogen, *L.donovani*. We therefore, thought that attempt could be made to control leishmanial infection either by modulating the surface receptor of macrophage or by identifying the signalling molecules generated say, kinases during early phases of *L.donovani*-macrophage i.e., ligand-receptor interaction. Identification of these types of molecules would help one to design suitable inhibitors for blocking the infections.

Although interaction of *L. donovani* with macrophages is known to be a ligand-receptor interaction, various aspects of macrophage surface receptor biology including:

i) modulation of receptors and its effect on the interaction process and ii) receptor signalling involving cell-cell interaction at the surface remain totally untouched. Work in this area will help us to understand the mechanism of controlling the infections and of intracellular survival of this pathogen.


