1. Student Coverage

Certificate course in Computer Application and Programming (CCAP) shall encompass the students from 1st year to 2nd year of college. The paid student strength undergoing Computer classes will be (Approx.). Pass out Students will get annual completion certificate after 1 year and after completion of 2nd year and above the students will get a Diploma course certificate.

2. Routine

The Principal or any authorized person of the Principal in consultation with WTI, will frame the routine for computer classes.

3. Electricity

The "College" shall provide electric connections for the computer classes for operations and functioning of the computers and other accessories. Electric charges for the same shall be borne by the "College"

4. Instructors

"WTI." will provide required instructors for conducting the Certificate course in Computer Application and Programming (CCAP) for these paid registrations. WTI. will provide one faculty member. (one M.C.A or equivalent/M.SC. /MTech/ with Computer Sc./IT & M.com/M.com with F.A. or equivalent etc.).

5. Syllabus

The syllabus of the Certificate course in Computer Application and Programming (CCAP), as prescribed by WTI, in consultation with the college will be followed.

6. Study materials & Stationery

College on their part will provide the following for smooth continuation of the program.

7. Fees


